

# 2022 Annual Drinking Water Quality Report Garrison RWD, Garrison, ND

We are pleased to present to you this year's *Annual Drinking Water Quality Report*. This report is designed to inform you about the safe clean water we deliver to you every day. Our constant goal is to provide you with a safe and dependable supply of drinking water. We want you to understand the efforts we make to continually improve the water treatment process and protect our water resources. We are committed to ensuring the quality of your water. Garrison Rural Water District purchases water from the city of Garrison.

Garrison Rural Water District is participating in the North Dakota Wellhead Protection Program. The ND Department of Environmental Quality will be preparing a Source Water Assessment for the City of Cleveland at a future date. Information on these programs will be made available to the public as they are completed.

The city of Garrison and Garrison Rural Water District in cooperation with the ND Department of Environmental Quality, has completed the delineation and contaminant/land use inventory elements of the North Dakota Source Water Protection Program. Based on the information from these elements, the ND Department of Environmental Quality has determined that our source water is "*not susceptible*" to potential contaminants. No significant sources of contamination have been identified.

This report shows our water quality and what it means.

Garrison Rural Water District would appreciate it if large volume water customers would please post copies of this year's *Annual Drinking Water Quality Report* in conspicuous locations or distribute them to tenants, residents, patients, students, and/or employees, so individuals who consume the water, but do not receive a water bill, can learn about our water system.

Garrison Rural Water District routinely monitors for contaminants in your drinking water per Federal and State laws. The following table shows the results of our monitoring for the period of January 1<sup>st</sup> to December 31<sup>st</sup>, 2022.

As authorized and approved by EPA, the state has reduced monitoring requirements for certain contaminants to less often than once per year because the concentrations of these contaminants are not expected to vary significantly from year to year. Some of our data [e.g., for organic or inorganic contaminants], though representative, is more than one-year-old.

The sources of drinking water (both tap and bottled water) include rivers, lakes, streams, ponds, reservoirs, springs, and wells. As water travels over the surface of the land, or through the ground, it dissolves naturally occurring minerals and, in some cases, radioactive material, and can pick up substances resulting from the presence of animals or from human activity.

Contaminants that may be present in source water include:

**Microbial contaminants**, such as viruses and bacteria, may come from sewage treatment plants, septic systems, agricultural livestock operations and wildlife.

**Inorganic contaminants**, such as salts and metals, can naturally occur or result from urban storm water, industrial or domestic wastewater discharges, oil production, mining, or farming.

**Pesticides and herbicides**, which come from a variety of sources such as agriculture, urban storm water runoff and residential uses.

**Organic chemical contaminants**, including synthetic and volatile organic chemicals, are by-products of industrial processes and petroleum production, and can, also, come from gas stations, urban storm water runoff and septic systems.

**Radioactive contaminants**, which can be naturally occurring or be the result of oil and gas production and mining activities.

To ensure that tap water is safe to drink, the Environmental Protection Agency (EPA) prescribes regulations which limit the number of certain contaminants in water provided by public water systems.

The Food and Drug Administration (FDA) regulations establish limits for contaminants in bottled water which must provide the same protection for public health.

In the following table, you will find many terms and abbreviations you might not be familiar with. To help you better understand these terms we have provided the following definitions:

**Not applicable (NA), No Detect (ND)**

**Parts per million (ppm) or Milligrams per liter (mg/l)** - one part per million corresponds to one minute in two years or a single penny in \$10,000.

**Parts per billion (ppb) or Micrograms per liter (µg/l)** - one part per billion corresponds to one minute in 2,000 years, or a single penny in \$10,000,000.

**Picocuries per liter (pCi/l)** –Pico curies per liter is a measure of the radioactivity in water.

**Action Level (AL)** - the concentration of a contaminant which, if exceeded, triggers treatment or other requirements which a water system must follow.

**Treatment Technique (TT)** - A treatment technique is a required process intended to reduce the level of a contaminant in drinking water.

**Maximum Contaminant Level** - The “Maximum Allowed” (MCL) is the highest level of a contaminant that is allowed in drinking water. MCLs are set as close to the MCLGs as feasible using the best available treatment technology.

**Maximum Contaminant Level Goal** - The “Goal” (MCLG) is the level of a contaminant in drinking water below which there is no known or expected risk to health. MCLGs allow for a margin of safety.

**Maximum Residual Disinfectant Level (MRDL)** – The highest level of a disinfectant allowed in drinking water. There is convincing evidence that addition of a disinfectant is necessary for control of microbial contaminants.

**Maximum Residual Disinfectant Level Goal (MRDLG)** – The level of a drinking water disinfectant below which there is no known or expected risk to health. MRDLGs do not reflect the benefits of the use of disinfectants to control microbial contaminants.

**Bacteriological Monitoring Data-TCR/RTCR: Total Coli Form Data: October** had the highest number of Total Coli Form Samples. **Total Coli Form Positives for that month: (1)** Coli forms are bacteria that are naturally present in the environment and are used as an indicator that other potentially harmful bacteria may be present.

**Violation: Lead/Copper Rule; Lead Consumer Notice:** During August 3, 2022 – November 17, 2022, Garrison RWD received a violation for failure to comply with the requirements of the Lead and Copper Rule. The Consumer Notice portion of the rule requires the system to notify the individual samplers of the level of lead in the samples that were taken and to certify the receipt back to the ND Department of Environmental Quality. Garrison RWD has taken steps to correct this violation by notifying samplers of the results of the samples taken and submitting the required certification form to the Department of Environmental Quality, Drinking Water Program.

\*If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. Garrison Rural Water District is responsible for providing high quality drinking water but cannot control the variety of materials used in plumbing components. **Use water from the cold tap for drinking and cooking. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking.** If you are concerned about lead in your drinking water, you may wish to have your water tested. EPA requires monitoring of over eighty drinking water contaminants. Those contaminants listed in the table above are the only contaminants detected in your drinking water.

Unregulated contaminants are those for which the EPA has not established drinking water standards. The purpose of unregulated contaminant monitoring is to assist the EPA in determining the occurrence of unregulated contaminants in drinking water and whether future regulation is warranted.

Drinking water, including bottled water, may be expected to contain at least lesser amounts of some contaminants. The presence of contaminants does not necessarily indicate that the water poses a health risk. MCL's are set at very stringent levels. To understand the possible health effects described for many regulated contaminants, a person would have to drink two liters of water every day at the MCL level for a lifetime to have a one-in-a-million chance of having the described health effect.

In our continuing efforts to maintain a safe and dependable water supply it may be necessary to make improvements in your water system. The costs of these improvements may be reflected in the rate structure. Rate adjustments may be necessary to address these improvements.

Thank you for allowing us to provide your family with clean, quality water this year. To maintain a safe and dependable water supply we sometimes need to make improvements that will benefit all our customers. These improvements sometimes require rate structure adjustments.

Some people may be more vulnerable to contaminants in drinking water than the general population. Immuno-compromised persons, such as, persons with cancer undergoing chemotherapy, persons who have undergone organ transplants, people with HIV/AIDS or other immune system disorders, some elderly, and infants can be particularly at risk from infections. These people should seek advice about drinking water from their health care providers.
